**TIMES:** Staggered start

**ELIGIBILITY:** Age as of December 31, 2009, Birth Certificates must be shown if challenged

**ENTRY FEE:** Pre-registration only: Mail in - \$20 (must be post marked by 2/1/10)

**RULES:** Modified PIAA rules, Double Elimination, sudden death overtime. Single wrestler in a weight class will be crowned champion. Less than three wrestlers in a weight class may be combined. Double entries are OK but no additional rest time will be allowed.

**AWARDS:** 1<sup>st</sup> - 4<sup>th</sup> Place for brackets of 16 or less wrestlers and 1<sup>st</sup> - 6<sup>th</sup> place for brackets of 17 wrestlers or more. Champion in each weight class will also receive a T-Shirt (Top three places qualify for Ohio Tournament of Champions and Gene Mills Eastern Nationals)
